

### **TERMS OF USE**

### **AGREEMENT TO TERMS**

These Terms of Use constitute a legally binding agreement made between User, whether personally or on behalf of an entity ("you", "your", "customer", "customers") and BlockBrew, along with its agents, assigns, and affiliates BlockBrew ("Company", "we", "us", or "our"), concerning your access to and use of the BlockBrew website as well as any other media form, media channel, or otherwise connected thereto which is controlled by the Company BlockBrew (collectively, the "Site").
